### **Tender content**

2. For the preparation of your tender you are encouraged to use the Proposal template provided, and consult the Special Tender Conditions (STC) Chapter 5, containing the required contents, including tables and forms to be presented as part of your Proposal.

## **Key Acceptance Factors**

With reference to the STC section 5.1, the Proposal template contains in Annex 2 a checklist of key acceptance factors. Your attention is drawn to the following:

- 2. Swarm DISC has agreed with ESA to earmark a budget of 100.000 EURO (Firm Fixed Price) for this activity. Please note that only proposals quoting a Firm Fixed Price in EURO within this limit will be considered for evaluation.
- 3. The planned duration must not exceed 12 months.
- 4. In submitting a tender, you are required to declare that you have read, understood and accepted the Swarm DISC Procurement Procedure, SW-RS-DTU-GS-003, rev. 2 (21 September 2020), and will respect the result of the evaluation.
- 5. Your tender must be valid for at least six (6) months from the Closing Date. Please note that this ITT does not bind Swarm DISC and/or ESA in any way with regard to any decision or action.
- 6. Your offer and all supporting documents must reach the Swarm DISC ITT mailbox (or FAX) stated above no later than the **Closing Date: 1 October 2024 at 12:00 GMT**. Tenders arriving after the Closing Date will not be evaluated.
